### FOR THE ROW

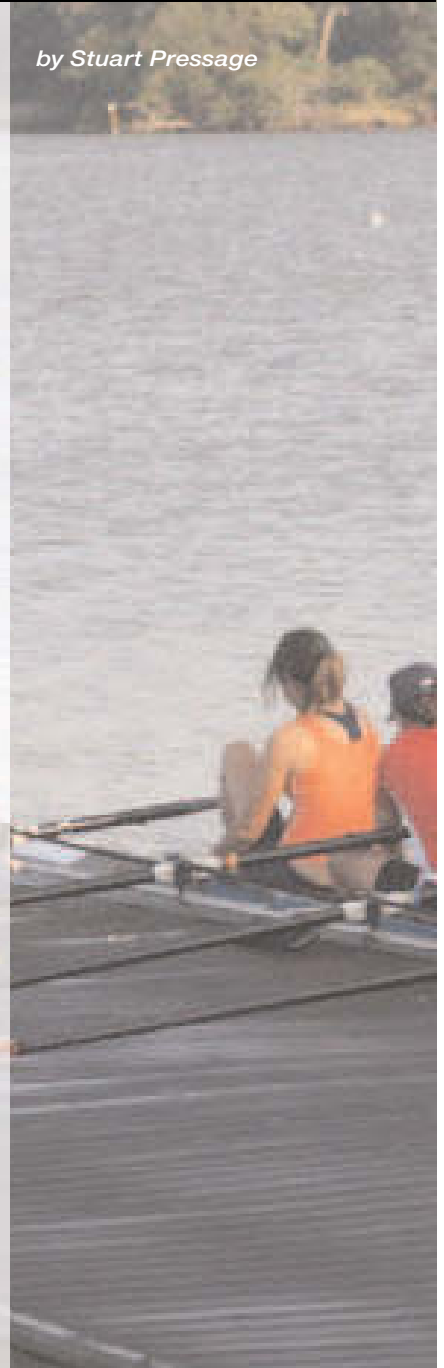

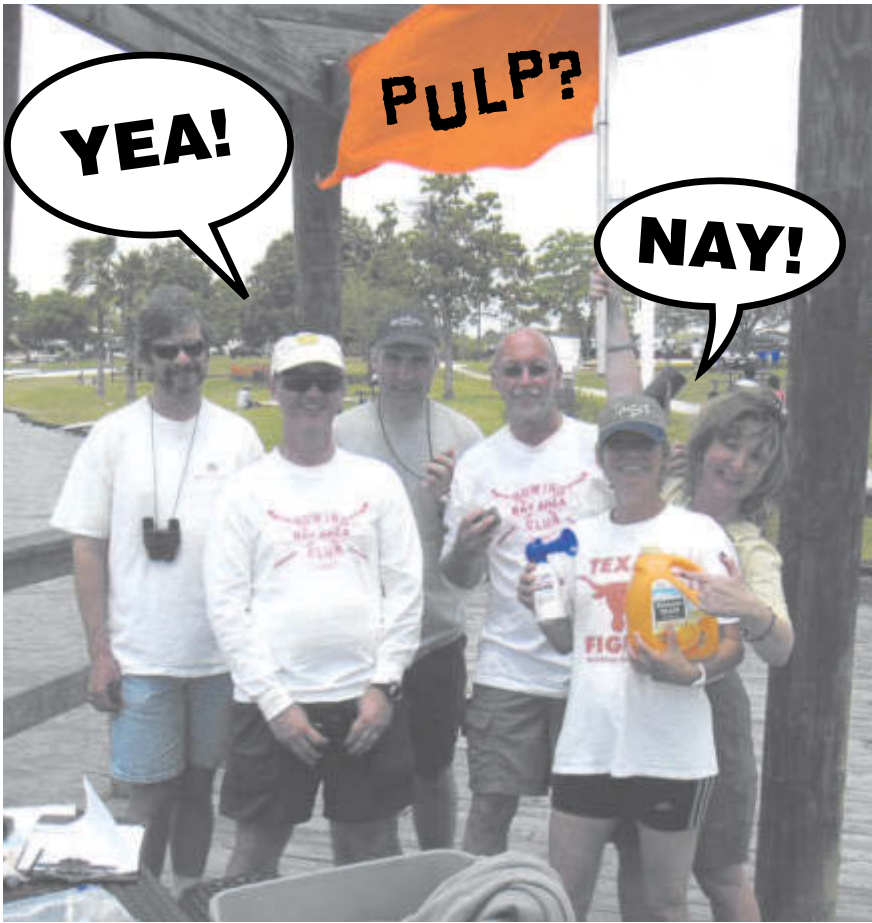

# BARC'S

## NEW CONCESSION AGREEMENT

By the time you read this article, **BARC** will (hopefully) have signed a new lease or "Concession Agreement" with Harris County, allowing us to stay at Clear Lake Park for at least another 10 years.

Getting to this point has not been easy: Even though the renewed agreement that the County initially presented to us was virtually unchanged from the one we've had for 15 years, The BARC Board of directors, looking out for interest of the club and its members, decided to scrutinize the language of the contract.

The way the original agreement was written, BARC is concessionaire, a business which rents boats to the public. While this, with some creative thinking, can be construed to be the case, it is hardly the way the club has been operating, nor is it a way we want to operate, so we suggested to change it to reflect what we really do: Promote the sport of rowing by offering memberships which allow members unlimited use of the club's facilities and equipment. The board also found it objectionable that **BARC** is being held liable for any incident, which may, at any time, occur within the "concession area" which include the docks, while we at the same time are required to allow the public access to the area at all times.

After many discussions and a consultation with an attorney, the board decided to suggest that these, and several other items be changed in the new agreement, and that opened up the proverbial can of worms.

The county's reaction to our request was a new version of the agreement in which the language about being a boat rental business had not changed, and the language about the liability was even less favorable for us than before. Furthermore, our percentage fee that we pay the county (of our total receipts) almost doubled from 6% to 11%.

Many e-mails and discussions followed, and we have finally convinced the county attorney to change the language to better reflect the way we conduct our business, but the higher fee and the liability is something we just have to live with if we want to stay in the park. We will likely have to pay more for insurance in the future to cover our liability. Other aspects of our operation may be affected as well, and our plans for expanding the boathouse will also have to be revisited. Stay tuned for more information, as we figure out what the full impact of the changes will be.

Once signed, a copy of the Agreement will be posted on the "Members Only" section of our website.
